



From the CEO

We've made good progress at ECHO over the summer with several new participants joining our programs, the arrival of new vehicles for our fleet, the launch of LIFE's morning "Breakfast Bar", some solid discussions with potential new worksites in the community, continued enhancements to the ECHO building, and the kick-off of our FY25 audit.

Many ECHO participants utilize Medicaid waivers and there is some anxiety about potential funding cuts as the federal government wrestles with getting the budget under control. We've been keeping our eyes and ears open over the past few months, and we are part of a network of private providers that stays close to legislative activity in both Washington and Richmond. Regarding H.R.1:

- 1) There does not seem to be any negative impact on services for developmentally disabled adults.
- 2) The primary focus is on the expansion population:
 - a. increased validation of their residency and eligibility.
 - b. decreased federal payments to states for emergency medical care
 - c. rules pertaining to work requirements.
 - d. cost sharing requirements to be implemented.
- 3) There is a delay in the implementation of the nursing home final rule until October 1, 2034.
- 4) Most of the provisions, such as creating a new option for a 1915c waiver, will require further guidance from CMS which will be forthcoming in the future.

We will continue to monitor and stay close to our network as more information is revealed. In the meantime, this does not seem to be a cause for concern for ECHO at this time.
